## Disclosing Fees Paid to BMV Vendors For E-Filing Lien Interests

Financial institutions offering auto loans to Indiana borrowers will soon be able to record their lien interests electronically. This electronic lien system is only provided by third-party vendors approved by the Indiana Bureau of Motor Vehicles (the “BMV”). These third-party vendors assess a fee to financial institutions directly for using the electronic filing service, but no fee is passed from the third-party vendor to the BMV – **as a result, any fees charged by the third-party vendor facilitating the electronic filing are not considered government fees.**

Financial institutions should carefully monitor how any fees paid to a third-party vendor for electronic lien filings in Indiana are disclosed on vehicle purchase agreements, loan agreements, and federal Truth in Lending disclosures. Because the payment made to the third-party vendor is not paid to a government agency, it is considered a prepaid finance charge under both the Indiana Uniform Consumer Credit Code (the “IUCCC”), and Regulation Z of the Truth in Lending Act, and must be disclosed as such. As a result, any fee paid to a third-party vendor for electronic lien filing in Indiana is subject to the two hundred dollar (\$200) maximum permissible prepaid finance charge limitation under the IUCCC applicable to both credit sales, and consumer loans.<sup>1</sup>
