## Michael McDaniel, Krieg DeVault Executive Director of Governmental Affairs, Receives Prestigious Allen C. Steere Award

In 1975 he served as Research Director for the City-County Council of Indianapolis. Mr. McDaniel has been involved in every



session of the Indiana General Assembly since 1974 when he began his career as a graduate student intern for then State Senator John Mutz.
