## Representative Experience

- Successfully upheld a \$500,000 no-fault benefits award to a decedent's estate in Michigan's 1st District Court of Appeals, overcoming an appeal by an AM Best A-rated insurer.
- Secured a ruling in the Illinois Appellate Court, 1st District, vacating the sentence of a defendant charged with firearm offenses, which included the UUWF and armed habitual criminal counts.
